
Is Coalition Acquiescence in MK-Ultra Gate Malfeasance Creating 'The New Normal' North and South of the 49th Parallel?

and

More Congressional Hearings That Weigh in on MK-Ultra Gate and the Transference Issue

It's certainly a watershed moment in human history. Either checks and balances in democracy that took almost a thousand years to evolve will be employed or one can expect that from now on there's going to be a devolution in civilization.

briefing -- a copy of the legal memo from OLC?

Holder: We will certainly look at that request and try to

determine...

Nadler: ...and a briefing to the members of this Committee?

Holder: And we'll certainly consider the possibility of a briefing.

Nadler: [44:14: O-S M.] A "possibility"? You won't commit to

giving a briefing to this Committee?



Same went for Congressman Lungren, and high profiling the lies and deceptions that perpetuated and concealed the MK-Ultra program. A distinguished and learned former member of the U.S. court also tears a strip off the Attorney General. Having been on the Bench and thus sensitive to abdications of responsibility by constituents of the administration of justice, Congressman Gohmert delivered a stinging indictment of his failings in bringing an end to what's been so inexplicably and intolerably drawn out.

I've been a Chief Justice of the Court of Appeals. At exactly the same time the Chairman of the Federal Reserve, who's been in the back-channel before while testifying before Congress was appearing before its Joint Economic Committee. Congressman Brady's query led Dr. Bernanke to drop his eyes in reaction to use of the lexicon.

A bit later, feeling as if he's got some responsibility to resolving the outstanding transference issue, he reminds everyone that it'll take both sides of the congressional isle to bring closure. .

All we've heard from the White House is silence [1:38: Newman M.]. But that's the story of the Obama administration. [...] The President and Senate Democrats are more interested in gimmicks than they are in real solutions [2:03: Cl.M.]. You know there is no better example than...

A few minutes later House Minority Leader Nancy Pelosi joins in. She's already felt Fourth Estate heat and knows that if this to date confidential situation blows up, she too will experience consequences. Five days later the Attorney General appears before Congress again and the pressure on his office to finish what was said to have been begun in February continued. First Senator Grassley highlights what is undeniable, namely that triggering a scandal that would dwarf Watergate is a looming constitutional crisis.

AG Holder: We want to make sure that if we do share that information it does not have an impact on on-going investigations. But, as I said, I'm willing to consider that as a possibility to try to avoid what I think is an impending constitutional crisis.
